# Context – Withdrawal Agreem

#### 31 January 2020 – Entry into force.

- Citizens' rights: protecting existing EU citizens in the UK, and UK nationals in the EU (excl. Ireland).
- Separation issues: e.g. goods placed on the market or data transfers before 1 January.
- Transition period: an effective EU member without voting rights.
- Financial settlement: honouring existing commitments.
- Ireland: avoid a hard border, protect the all-island economy and the Good Friday Agreement, and safeguard the integrity of the EU Single Market.



## **Policy - Ibec position**

- A smooth exit
- Comprehensive transitional arrangements
- Unique Irish challenges addressed (no hard border, CTA)
- Closest possible future relationship
- A prosperous, competitive future EU



#### Main issues – For Irish Business

#### • Trade in goods:

- Rules of Origin provisions
- Customs procedures and delays

#### • Trade in services:

- Restricted, fragmented and complex conditions
- Data flows
- Financial services
- Brexit & Future EU

- Protocol on Ireland and Northern Ireland
  - Mutual recognition of professional qualifications
  - NI inputs or processing in Irish exports

## Overview – EU-UK TCA

#### Three binding agreements:

- 1. Free Trade Agreement, incl. broader cooperation (economic, social, environmental etc.);
- 2. Partnership on citizens' security;
- 3. Overarching governance framework.

...complemented by a series of non-binding joint and unilateral political declarations.



# Content – EU-UK TCA

- 1. Common and Institutional Provisions
- 2. Trade, Transport, Fisheries and other arrangements (including social security coordination)
- 3. Law Enforcement and Judicial Cooperation in Criminal Matters
- 4. Thematic Cooperation
- 5. Participation in Union Programmes, Sound Financial Management and Financial Provisions
- 6. Dispute Settlement and Horizontal Provisions
- 7. Final Provisions



# Overview – Trade in goods



- 1. Zero tariffs and zero quotas if compliant with the rules of origin requirements
- 2. Full **bilateral cumulation**
- 3. No diagonal cumulation
- 4. All existing **geographical indications** remain protected



## Main issues – Trade in goods

- 1. Rules of Origin:
  - EU -> GB -> IE
  - 3rd country -> GB -> IE
- 2. Customs procedures (IE-GB):
  - Import requirements from 1 January
  - Export requirements gradually introduced



#### 3. Tax compliance:

- VAT payable on IE-GB transactions
- Registration of GB suppliers for IE Vat
- 4. Future regulatory divergence
  - Freedom to diverge if it does not create unfair competition





#### Overview – Trade in services

- 1. Market access for services
- 2. National treatment
- 3. Local presence
- 4. Short-term business trips
- 5. Most-favoured nation clause



## Main issues – Trade in services

- 1. Specific measures for some services:
  - e.g. Telecommunications and delivery
- 2. Exceptions between EU Member States:
  - Local requirements e.g. language
- 3. Professional qualifications:
  - No mutual recognition
  - Structure to assess requests



#### 4. Tax compliance:

- VAT payable on IE-GB transactions
- Registration of GB suppliers for IE Vat
- 5. Future regulatory divergence
  - Freedom to diverge if it does not create unfair competition

## Overview – Digital trade and data



- Agreement against barriers to trade such as requiring data localisation for storage or processing.
- Protections for personal data.
- Electronic contracts permitted with exceptions, incl. broadcasting, gambling and legal.
- Commitment to cross-border data flows.
  - EU -> UK data transfers facilitated for 4-6 months while EU concludes a data adequacy decision.
