

# Mexico

# Irish Water faces land CPO appeal

A BUSINESSMAN and a cashand-carry firm have brought a legal challenge to Bord Pleanála's decision to grant a compulsory purchase order (CPO) for land Irish Water says it needs to increase the capacity of a Kildare sewerage system and reduce overflows into the River Liffey.

Irish Water wants to increase capacity of the system serving Newbridge to facilitate future growth of the town. It needs to upgrade the Upper Liffey Valley Sewerage Scheme by laying 9.9km of pipes between Kilbelin, south of Newbridge, and Oberstown waste treatment plant, to the west of Naas.

It requires land owned by businessman Dermot Cox, Rosetown Stud, Athgarvan, Newbridge, and occupied by Thurles Wholesale Cash and Carry, with registered offices at Kilbelin. Both parties lodged objections to CPOs sought by Irish Water over the land.

Last November, An Bord Pleanála recommended the CPO be confirmed without modification.

Yesterday, Irish Water applied to have the case dealt with through the fast-track Commercial Court because of its urgency.

Mr Justice Brian McGovern admitted it to the commercial list and set a provisional hearing date in July.

In an affidavit supporting the fast-track application, Brian Sheehan, an engineer employed by Irish Water's parent company, Ervia, said the improvement works were urgently needed because the treatment plant at Oberstown in Naas has already been specifically referenced in infringement proceedings by the EU against Ireland in the Court of Justice of the EU.

# MSD patent dispute fast tracked in High Court

PHARMACEUTICAL giant Merck Sharp & Dohme (MSD) has claimed in court that a rival is breaching its patent rights by trying to sell a generic version of a drug for less than a tenth of the price of MSD charges.

MSD Ireland chief executive Gerard Brennan said if Clonmel Healthcare was allowed to continue selling the drug, the loss of market share in Ireland and abroad "will be felt" by the 150-strong workforce at MSD's plant in Ballydine, Clonmel.

That plant manufactures simvastatin, the active ingredient for the Inegy, which in Ireland is used by around 15,000 people a month to combat high levels of cholesterol in the blood, the main cause of cardiovascular diseases that are the chief cause of death in the Western world.

Some 50pc of Ballydine's output constitutes simvastatin. Inegy itself is worth around €8m a year to MSD, Mr Brennan said.

On Monday, Mr Justice Brian McGovern admitted MSD Incorporated's action against Clonmel Healthcare to the fast-track Commercial Court.

He also adjourned the hearing of an application to continue a temporary injunction, granted last week, preventing Clonmel from marketing and

distributing its version of Inegy, called Ezetimibe/Simvastin. Clonmel launched its product early last week.

MSD says Clonmel – part of the Stada AG publicly-quoted group based in Germany – is infringing its patent rights, or supplementary protection certificate.

In an affidavit, Mr Brennan said the entry of Clonmel into the Irish market with its generic version, offered "at a fraction of the existing price of Inegy" will result in a massive distortion to the market that will cause irreparable and unquantifiable damage to MSD.

MSD, one of the world's top 10 largest pharmaceutical companies, has spent more than \$7.3bn (£5.94bn) on research and development, he said. MSD's exclusive rights in relation to products containing ezetimibe in a combination with simvastatin have been extended until April 2019, he said.

If Clonmel – of Waterford Road, Clonmel, Co Tipperary – is not restrained from infringing MSD's rights, four other generic companies that have already obtained authorisations to sell generic Inegy will be "commercially compelled to enter the market", Mr Brennan believes.
